"CERTIFICATE"

Department of Education, H.P. has no objection to permit the management of Holy Angels School Tegubeh (Shamshi) Teh. & Distt. Kullu (H.P.) to seek affiliation to H.P. Board/I.C.S.E/C.B.S.E. New Delhi upto 6th to 8th Classes.

The grant of this permission shall however not entitle the school to any grant-in-aid from the Deptt./Govt. of H.P.

This NOC is issued subject to the following conditions :-

1. No Pupil shall be refused admission on account of his caste, creed or religion and the pupil who has once been admitted shall not be treated differently from the other fellow pupil of his caste, creed or religion.
2. No Pupil shall be compelled to attend a class in which a religious instruction is given or take part in any religious exercises.
3. The school with its accounts books, registers and other records shall be open to inspection at all reasonable hours by the authorised officer of the Department, Executive Officers of the Govt. Health Deptt. to examine the health of the students or sanitary condition of the building and premises.
4. The school shall have to furnish all information and returns as called for by the Department from time to time.
5. The school shall comply with the rules of the Department and direction as given by the Department so far as they are applicable to private schools in the interest of maintaining Education standard. The Deptt. of Education shall have the authority to send any of Officer for inspection for proper maintenance of Education standard holiday as per State Govt. etc.
6. The school staff and students shall not take part in any agitation directed against the authority of Govt. or disseminate opinions tending to excite feelings of disloyalty or disaffection against the Govt. of of entity and hatred between different communities.
7. The school shall charge the rate of tuition fee and subscription to boys funds in accordance with the scales prescribed or approved by the Education Department of H.P./CBSE/ICSE and schools shall have to submit a class-wise list of tuition fee and funds to this office.
8. The school shall maintain the discipline properly.
9. The school shall take steps to promote the use of Hindi. The extent of reservation for SC/ST students at the time of admission be adhered to.
10. The school shall have to work within the frame work of National Priorities.
11. In the matter of appointments of teaching and non-teaching staff preference will be given to Himachalies. Policy of reservation in appointment of staff will have to be taken into accounts as per practice prevailing in Govt. institutions.
12. Free Education will be impacted to the girls students.

The breach of any of the conditions specified above shall render the school defaulter and the Dy. Director of Education concerned/head of the Deptt. conducting inspection through any of the Officers assigned by him, shall have the power to cancel the N.O.C.
